REQUEST FOR EXPRESSIONS OF INTEREST

1. This request for expression of interest follows the General Procurement Notice for the Tanzania Longido district council issued on 20<sup>th</sup> September,2018.

The Longido District Council Through its collection of own source fund and fund expected to receive from the central government (Government of the United Republic of Tanzania ). It is intended that part of the proceeds of the credit will be used to cover eligible payments under the contract for **the provision of consultancy services by conducting feasibility study, design and submission of proposal in strategic projects as following;**

- i) conducting feasibility study and submission of proposal for construction of modern bus stand at Longido town with the initial cost not less than Tshs 3.5 billions
- ii)To conduct feasibility study on commercial pond fish farming(tilapia production) the proposed ponds size for this project is 10,000 sq metres with estimated cost Tshs 5 Billions
- iii) To conduct feasibility study on development of meat industry with capacity proposed of processing 2000 Goats and 200 Cattle a day with estimated cost Tshs 9 billions
- iv) To conduct feasibility study and proposal of strategic livestock and crop market with Estimated cost of Tshs 3 billions
- v) To conduct feasibility study and proposal for establishment of commercial bee farm with cost estimated to worth Tshs 2,500,000,000.00
- vi) To conduct feasibility study and proposal for construction of modern landfill(Dumping)site with the initial cost of not less than Tshs 2 billions
- vii) To conduct feasibility study and proposal for Dam Construction with embankment of 1000 metres

2. **The objective** of the assignment is to increase the councils revenue sources through establishment of strategic projects. The priority projects should be prepared such that it could be presented to donors for possible support.
3. The Longido District Council now invites eligible consulting firms ("Consultants") to indicate their interest in providing the Services. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services. The short listing criteria are: (i) general experience in development/implementation of intended strategic projects; (ii) experience in undertaking feasibility studies and design of strategic project mentioned above; and (iii) successful execution of at least two similar projects (by size and complexity) in an urban or peri-urban environment in developing countries. Information to be provided should include name of assignment, name and full contact address of the client, specific input, experts and tasks performed by the consultant under the assignment, assignment value, period (dates) of execution of assignment, etc.

Interested firms must provide information indicating that they are qualified to perform the services by submitting consultant's profile, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc. Consultants may associate to enhance their qualifications .

4. This is **not** a request for proposals (**RFP**). After a review of the expressions of interest, a shortlist will be prepared and the short-listed consultants will be invited to submit their proposals through a letter of invitation including specific terms of reference. Consultant will be selected in accordance with the procedures set out in the public procurement Act no 7 of 2011 and the public procurement(selection and employment of consultants
5. Selection will be conducted through the selection based on consultants qualification selection procedures specified in the public procurement regulations
